



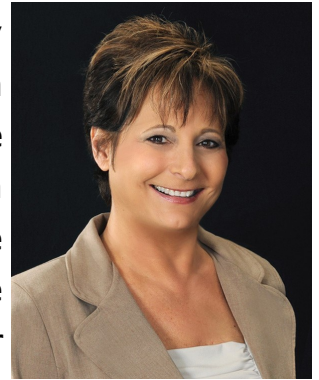

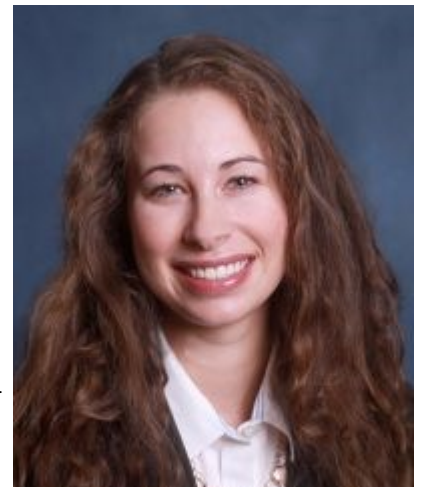

April 4th is Legislative Day and I hope to see many of you there. Just as a reminder, we will start our day at 9:15 am with a tour of the Legislative building followed by viewing the Assembly or Senate floor meeting with a Republican legislator; followed by lunch. After lunch, from 1:00-4:00, various Republican legislators will speak for about ten minutes each on a variety of subjects. If there is enough interest, we will also tour the State Capital.

Over 1200 Bill Draft Requests (BDR's) have been submitted thus far and the deadline now has been extended to March 25 for bills to be introduced in their committee.

A few of the bills to keep monitoring are:

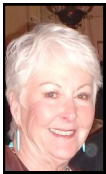
AB281 – Makes Nevada a Sanctuary State

AB186 – National Popular Vote (does away with the Electoral College)

SB123 – Same Day Voter Registration and Voting on Election Day

SB179 – Revises Provisions Relating to Abortions

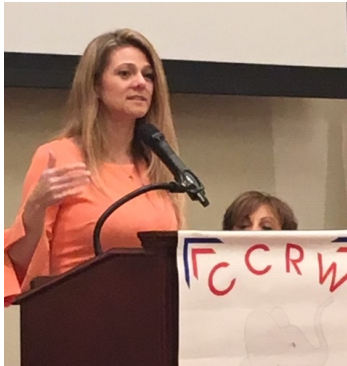
