I suspect we will hear some of the other Presidential Candidates start to speak about the "Alien and Sedition Acts." This Act was a set of four laws enacted in 1798 that applied restrictions to immigration and speech in the United States. The Naturalization Act increased requirements for Citizenship. The Alien Friends Act allowed the president to imprison and deport non-citizens.

The Alien Enemies Act gave the president the power to imprison and detain non-citizens during war. The Sedition Act criminalized false and malicious statements about the Federal Government. I have included the link for you to research more on this subject; too much for me to share. Most of these laws have expired, but except one, the Alien Enemies Act was not allowed to expire with the other Alien and Sedition Acts and remains in effect: Chapter 3, Section 21-24 of Title 50 of the United States Code. Under this law, the president could authorize the arrest, relocation, or deportation of any non-citizen male residing in the United States who was 14 years or older. This discussion on the Alien Enemies Act is just food for thought, as we will have to address this issue at some point, and most Americans are furious about our porous borders. 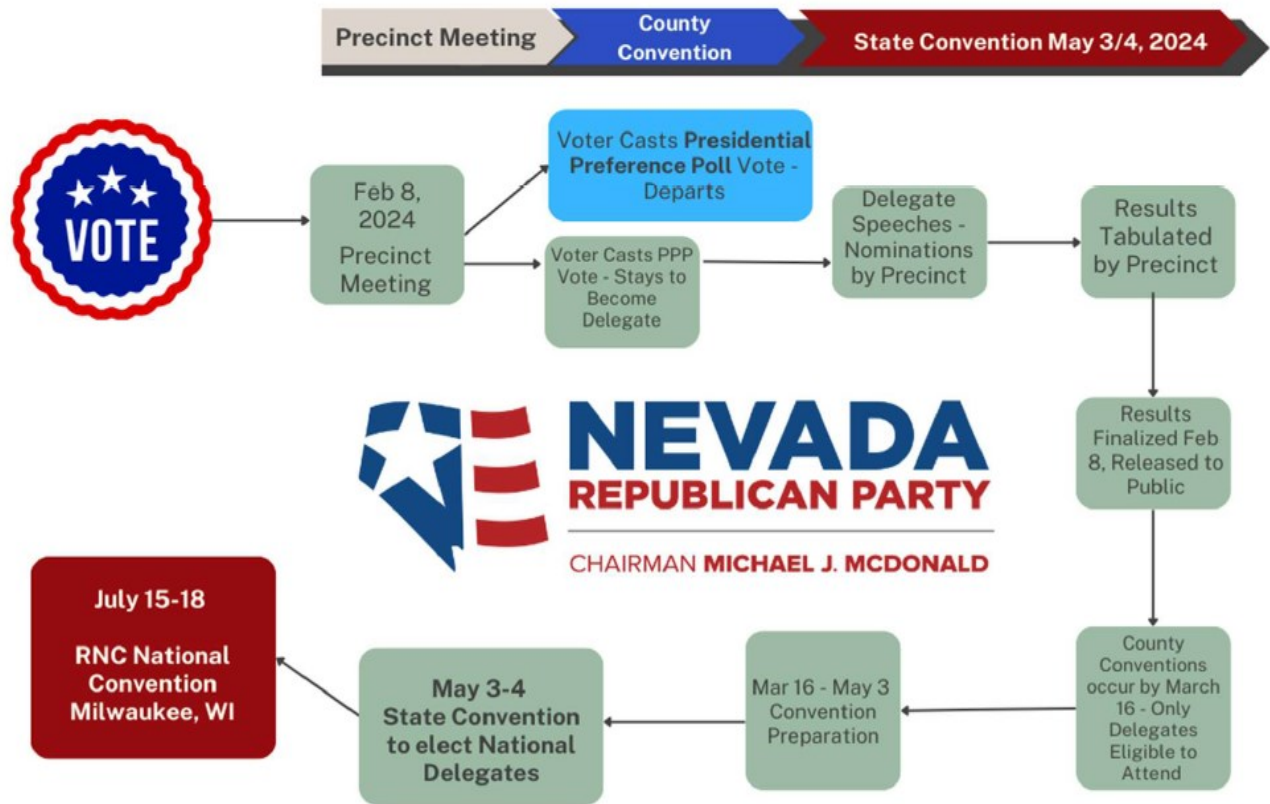

## Caucus Agenda

---

- Voter arrives at his or her caucus location.
- Voter eligibility is verified and voter is checked in.
- Voter is given his or her preference poll ballot and directed to his or her precinct location.
- Election of precinct caucus chair and secretary.
- Election of delegates to the county conventions.
- Short speeches by each presidential candidates campaign or designated speaker.
- Miscellaneous county party business.
- The presidential preference poll (by secret ballot)





## Caucus Mechanics

---

- **Absentee voting** is available to members of the military and their dependents who are stationed outside their home county.
- **Organization:**
  - The caucuses and the accompanying presidential preference poll are run by the Nevada Republican Party and the county Republican parties.
  - A statewide Caucus Team coordinates the activities.
  - Location Captains are appointed for each caucus location. Typically, several precinct caucuses will be held at the same location.
  - Precinct Captains are first appointed and then elected to run each precinct caucus.



## Caucus Mechanics

---

- **Ballot Tabulation:**
  - Once balloting ends, Precinct Captains will count the results for their precinct in the presence of the attendees, record the results on an envelope, and then enclose the ballots in an envelope.
  - Each location will have a Teller Committee who will collect the balloting envelopes from the Precinct Captains, verify the count and sum up the results by location. Each candidate will be permitted to have official campaign observers during this process.
  - Once ballot totals are verified, the Location Captain will report the results to the county Republican parties and the Nevada Republican Party.
  - The Nevada Republican Party will publicly post results by county and precinct on the website so that all voters can confirm their vote was counted correctly.

## Mike Lindell says MyPillow has been crippled by American Express slashing their credit line: 'We really need everybody's help right now'

- Mike Lindell said MyPillow was left crippled after American Express slashed their credit line.

"No reason, no explanation, just dropped it down last Tuesday," he said on the ["War Room"](#) podcast.

A Minnesota bank previously terminated Lindell as a client after calling him a "reputation risk."

MyPillow CEO [Mike Lindell](#) said that his company has been crippled by [American Express's](#) decision to slash its credit line.

"Steve, we really need everybody's help right now. We have things going on I'm going to let you all know this week," Lindell told fellow Trump ally Steve Bannon on the latter's ["War Room"](#) podcast on Monday.

Lindell said on the podcast that a sudden reduction in MyPillow's credit line with American Express was seriously affecting the company. Lindell told Bannon that MyPillow had been using American Express's services for the past 15 years.

"Out of the blue, they took our credit line from a million dollars down to \$100,000," Lindell said. "Just cripples MyPillow. No reason, no explanation, just dropped it down last Tuesday."

A spokesperson for American Express told Insider that they weren't able to address Lindell's claims directly.

"We can't comment on specific customer accounts or applications, but I can tell you that American Express does not make customer decisions based on personal views or political affiliations," the spokesperson said.

This isn't the first time Lindell has had trouble securing credit for his company.

In February 2022, Lindell was [terminated as a client by the Minnesota Bank & Trust](#) a month after the bank called him a ["reputation risk."](#)

The pillow magnate has been a staunch advocate of [former President Donald Trump's groundless election fraud claims](#). Lindell's avowed support for Trump, however, has greatly impacted his pillow business.

In July, Lindell [auctioned off equipment from his pillow factory in Minnesota](#). Lindell said at the time that he was hawking equipment after the company lost more than \$100 million in retail sales.

Lindell is also fending off a [billion-dollar defamation lawsuit](#) from voting technology company [Dominion Voting Systems](#), and another from [Smartmatic](#) over claims that he made about both companies' role in the 2020 election.

Representatives for MyPillow did not immediately respond to a request for comment from Insider sent outside regular business hours.

I'll close with this quotable from Oscar Wilde: "If you don't get everything you want, think of the things you don't get that you don't want." Blessings to all of you!





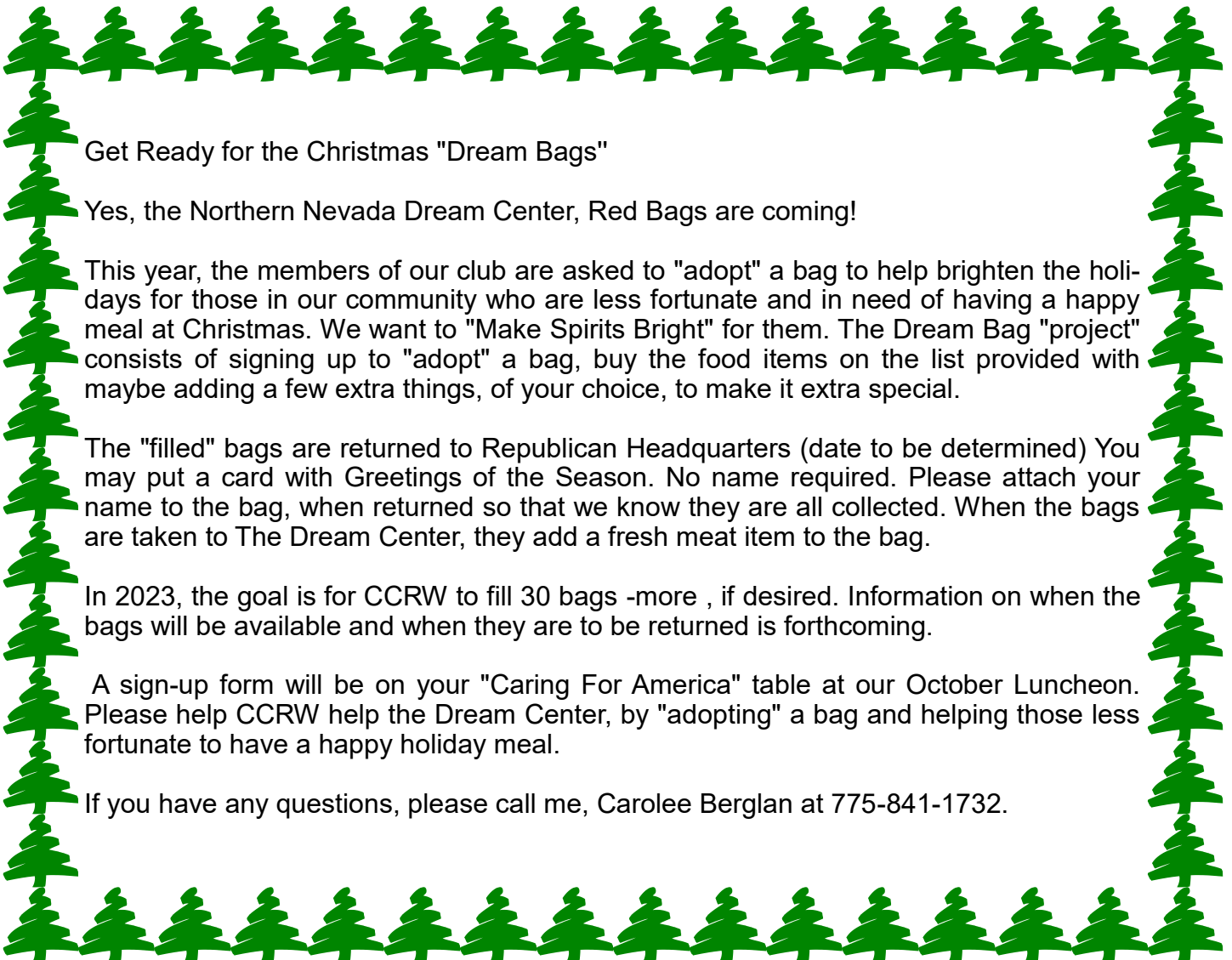

## An interesting bit of history...



### POW & MIA BRACELETS

Nickel-plated and copper bracelets, created about May of 1970, had the rank, name, and 'loss' date engraved on the bracelet.

During the Viet Nam war, 726 soldiers were taken prisoner and or killed. Of those, 661 were returned. Two college students came up with the idea to make bracelets to increase awareness of the ongoing war without controversy so our POWs would not be forgotten.

Nickel bracelets cost 30 cents to make, and copper was 75 cents. They sold for \$2.50 and \$3.00. **Over four million were sold, with \$7 million raised.** Movie stars, fashion models, and grandparents wore them. They were worn all the time, only taken off to shower. They often turned the skin green, prompting many people to line the inside of the bracelet with clear nail polish.

When the POW came home, the bracelets were often given to the soldier. There are three on display at the National Museum of American History in Washington, D.C.
