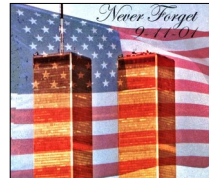

### John Tsarpalas – Nevada Policy Research Institute



John Tsarpalas is the President of the Nevada Policy Research Institute and is deeply committed to spreading limited government ideas and policy to create a better, more prosperous Nevada for all.

John spent the first 25 years of his career as a commercial construction contractor in Chicago. As government regulations and state and local taxes expanded exponentially in his home state of Illinois, he realized that, as a business owner, he had to become more active in the world of politics.

In 1996, when Newt Gingrich drafted the Contract with America, John became active in Republican political campaigns. After five campaigns where his candidates were the only Republicans elected in Democrat districts, he was recruited to become the Executive Director of the Illinois Republican Party in 2005. As Executive Director he graduated from the Republican National Committee's Campaign College and the RNC's Field Management School.

After being terribly disappointed by Republican votes in the Illinois State House and Congress, John left the party to pursue alternate routes to making change. As President of the Sam Adams Alliance the focus was on educating activists and building support organizations to help the free enterprise and limited government movements in 10 states. On the national level he was part of the team that started the Franklin Center for Government & Public Integrity and American Majority with chapters in 23 states.

After the Sam Adams Alliance, John partnered to start the following educational not-for-profits: Think Freely Media, the Haym Salomon Center for Jewish American Thought, and Midwest Speaking Professionals.

A former native of the economically and politically bankrupt state of Illinois, John now lives in Henderson, Nevada, with his wife of 41 years.

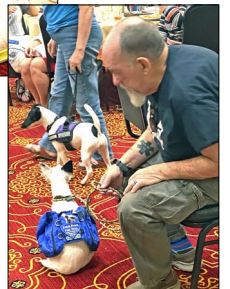
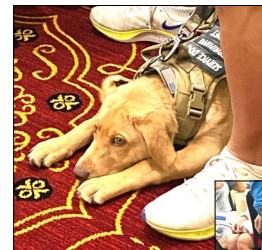

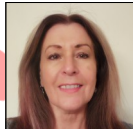

## LEGISLATIVE CRIER

### Susan Ruch—Legislative Chair · The Invasion of Illegals



The Biden administration has demonstrated they have a diabolical plan to change the United States into a country that we no longer recognize, one world order or Agenda 21. All one has to do is read and listen to the news. Every day the news is more discouraging and it appears we will lose our county forever as millions of illegals stream across the southern border. The mainstream medias are not interested in being investigative reporters (it doesn't fit the narrative) as they cover for the Biden Administration. The average American only watches approximately 20 minutes of news a day so they are not informed of the true facts. The invasion of illegals from our southern border is changing the landscape of America for many years to come.

I was told by someone locally they have shipped 1,000 into Carson City. Where are they, who is responsible, and do they have covid? How many are children? ## LABOR DAY

Observed the first Monday in September, Labor Day is an annual celebration of the social and economic achievements of American workers. The holiday is rooted in the late nineteenth century, when labor activists pushed for a federal holiday to recognize the many contributions workers have made to America's strength, prosperity, and well-being.

Before it was a federal holiday, Labor Day was recognized by labor activists and individual states. After municipal ordinances were passed in 1885 and 1886, a movement developed to secure state legislation. New York was the first state to introduce a bill, but Oregon was the first to pass a law recognizing Labor Day, on February 21, 1887. During 1887, four more states – Colorado, Massachusetts, New Jersey and New York – passed laws creating a Labor Day holiday. By the end of the decade Connecticut, Nebraska and Pennsylvania had followed suit. By 1894, 23 more states had adopted the holiday, and on June 28, 1894, Congress passed an act making the first Monday in September of each year a legal holiday.

Who first proposed the holiday for workers? It's not entirely clear, but two workers can make a solid claim to the Founder of Labor Day title.

Some records show that in 1882, Peter J. McGuire, general secretary of the Brotherhood of Carpenters and Joiners and a co-founder of the American Federation of Labor, suggested setting aside a day for a "general holiday for the laboring classes" to honor those "who from rude nature have delved and carved all the grandeur we behold."

But Peter McGuire's place in Labor Day history has not gone unchallenged. Many believe that machinist Matthew Maguire, not Peter McGuire, founded the holiday.

Recent research seems to support the contention that Matthew Maguire, later the secretary of Local 344 of the International Association of Machinists in Paterson, New Jersey, proposed the holiday in 1882 while serving as secretary of the Central Labor Union in New York.

According to the New Jersey Historical Society, after President Cleveland signed the law creating a national Labor Day, the *Paterson Morning Call* published an opinion piece stating that "the souvenir pen should go to Alderman Matthew Maguire of this city, who is the undisputed author of Labor Day as a holiday." Both Maguire and McGuire attended the country's first Labor Day parade in New York City that year.

The first Labor Day holiday was celebrated on Tuesday, September 5, 1882, in New York City, in accordance with the plans of the Central Labor Union. The Central Labor Union held its second Labor Day holiday just a year later, on September 5, 1883.

By 1894, 23 more states had adopted the holiday, and on June 28, 1894, President Grover Cleveland signed a law making the first Monday in September of each year a national holiday.
